**RESOLUTION NO. 478-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2, S-2024 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE ON THE ESTABLISHMENT OF TEEN CENTER IN THE MUNICIPALITY OF URBIZTONDO, PANGASINAN AND PROVIDING ITS MANAGEMENT AND OPERATION PROCEDURES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Ordinance No. 2, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 17 (a) (b) (2) (iv) and 447 (a) (5) (xiv) and Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act) of R. A. No. 7160;

**WHEREAS**, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to prepare a supplemental appropriation (Supplemental Budget) to implement the subject Ordinance;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 of R.A. No. 7160;
