DECLARING MUNICIPAL ORDINANCE NO. 2, S-2024 OF THE BAYAN OF BINMALEY, PANGASINAN, SANGGUNIANG ENTITLED "AN ORDINANCE AMENDING SECTION 2 OF **MUNICIPAL ORDINANCE NO. 15, SERIES OF 2023, ENTITLED** "AN **ORDINANCE** CREATING THE **POSITION** OF ADMINISTRATIVE AIDE II (MESSENGER), SG 2, UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG BAYAN OF THE LEGISLATIVE DEPARTMENT OF THE MUNICIPALITY OF BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED **POWERS OF THE SANGGUNIAN TO ENACT**

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with the Qualification Standard issued by the Civil Service Commission and the Local Budget Circular No. 137 dated July 13, 2021 (Index of Occupational Services, Position, Titles and Salary Grades in Local Government (IOS-LGU), CY 2021 Edition;
