**RESOLUTION NO. 502-2024**

**DECLARING ORDINANCE NO. 083, S-2024 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 2 (7) (A) AND SECTION 3 (F) OF ORDINANCE NO. 072-2021 ENTITLED “AN ORDINANCE CREATING THE OFFICE OF THE HUMAN RESOURCE MANAGEMENT (HRMO) AND OFFICE OF THE MUNICIPAL MANPOWER DEVELOPMENT AND VARIOUS PLANTILLA POSITIONS IN EXECUTIVE AND LEGISLATIVE DEPARTMENTS OF THE MUNICIPAL GOVERNMENT AND ABOLISHING THE PLANTILLA POSITIONS OF SUPERVISING ADMINISTRATIVE OFFICER (HRMO IV) IN THE MUNICIPAL MAYOR AND AGRICULTURAL TECHNOLOGIST IN THE OFFICE OF THE MUNICIPAL AGRICULTURIST” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 083-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Budget Office, and Civil Service Commission have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76, and 447 (a) (1) (viii) of R. A. No. 7160; Qualification Standard issued by the Civil Service Commission and the Local Budget Circular No. 137 dated July 13, 2021 (Index of Occupational Services, Position, Titles and Salary Grades in Local Government (IOS-LGU), CY 2021 Edition;
