PROVINCIAL RESOLUTION NO. 545-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT 1 AND THE ABONO PARTYLIST REGARDING THE CLOSURE OF AN ACCOUNT AT THE LAND BANK OF THE PHILIPPINES – DAGUPAN CITY BRANCH RELATIVE TO THE PHASE II ACCELERATED CERTIFIED SEED PRODUCTION AND DISTRIBUTION PROJECT IN PANGASINAN

WHEREAS, Resolution No. ACSPDP-01, Series of 2012 requested the Provincial Government of Pangasinan, the Department of Agriculture Regional Field Unit 1 and Abono Partylist to enter into an Addendum Memorandum of Agreement for the opening of an account with the Land Bank of the Philippines-Dagupan City Branch anent the implementation of Phase II Accelerated Certified Seed Production and Distribution in Pangasinan;

WHEREAS, pursuant to the Addendum Memorandum of Agreement, dated June 8, 2012, the abovementioned Parties had opened an account with the Land Bank of the Philippines – Dagupan City Branch bearing the name of DA Pangasinan Research and Experiment Center and with Bank Account No. 00000822109586 on May 8, 2013;

WHEREAS, the implementation of the said Project was already completed and ended in 2016, however, the funds deposited at the bank cannot be utilized by the Department of Agriculture since the usage of the funds have already lapsed in 2018;

WHEREAS, relative thereto, the Land Bank of the Philippines – Dagupan City Branch has declared the bank account dormant in 2023 and the Department of Agriculture has already been advised by the Commission on Audit to close the said account so that the remaining funds could be returned to the Bureau of Treasury;

WHEREFORE, in view of the foregoing, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


