RESOLUTION NO. 575-2024

DECLARING MUNICIPAL ORDINANCE NO. 3, S-2024 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION FOR ADMINISTRATIVE OFFICER III, (SUPPLY OFFICER II), SG-14 IN THE OFFICE OF THE MUNICIPAL MAYOR, LOCAL GOVERNMENT UNIT OF BAUTISTA, PANGASINAN AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Ordinance No. 3, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to prepare a supplemental appropriation (Supplemental Budget) for the implementation of the said ordinance;


