PROVINCIAL RESOLUTION NO. 584-2024

APPORTIONING TWO HUNDRED SQUARE METERS (200 SQ.M.) OF LOT FOR THE ESTABLISHMENT OF SOLAR POWERED PUBLIC WATER SUPPLY SYSTEM – LEVEL II AT THE LINGAYEN GULF RESETTLEMENT SITE IN BRGY. PANGAPISAN NORTE, LINGAYEN, PANGASINAN

WHEREAS, Presidential Proclamation No. 499 issued by President Fidel V. Ramos on October 28, 1994, reserved and declared for resettlement and development site purposes certain parcels of land of the public domain located in Brgys. Maniboc and Pangapisan Norte, Lingayen, Pangasinan under the joint administration of the Provincial Government of Pangasinan and the National Housing Authority;

WHEREAS, Lot 2, Nr-015522-00 of said Proclamation and situated in Brgy. Pangapisan Norte, Lingayen, Pangasinan had been developed by the Provincial Government of Pangasinan and the National Housing Authority as site of the 13-hectare Lingayen Gulf Resettlement Site;

WHEREAS, Republic Act 7279, known as the Urban Development and Housing Act of 1992, provides for a comprehensive and continuing urban development, specifically Section 21 of this Act which mandates LGUs to provide for the upliftment of the underprivileged and homeless citizens in resettlement areas by making available to them basic services and facilities, such as but not limited to water supply system, in coordination with concerned agencies;

WHEREAS, the Department of Public Works and Highways (DPWH), thru the Pangasinan 2nd District Engineering Office will construct a Level II Water Supply System at the resettlement site in Brgy. Pangapisan Norte, Lingayen, Pangasinan under the Basic Infrastructure Program – Public Water Supply System;

WHEREAS, a Two Hundred Square Meter (200 sq. m.) lot within the coverage of Lot 2, Proclamation No. 499, has been identified as proposed site for the establishment of a Solar Powered Public Water Supply System – Level II, to meet the water supply requirements of the residents at the resettlement area;

WHEREAS, in consonance with Republic Act 7279, the Province and NHA needs to apportion a parcel of land for the above purpose which is described and bounded as follows:

“The southeastern portion of the open area within the lot designated as Lot 2, Nr-015522-000020) within the coverage of Presidential Proclamation No. 499 located in Brgy. Pangapisan Norte, Lingayen, Pangasinan with an area of TWO HUNDRED SQUARE METERS (200 sq. m.), more or less, bounded on the North by open ground; on the East by 3.00 m. wide road; on the West by a covered court; and on the South by Aplaya Day Care Center”.


NOW THEREFORE, on motion of SP Member Philip Theodore E. Cruz, duly seconded, it was;

RESOLVED, by the Sangguniang Panlalawigan of Pangasinan, in session assembled to apportion, as it is hereby apportioned, a Two Hundred Square Meter (200 sq. m.) lot within the coverage of Lot 2, Proclamation No. 499, for the establishment of a Solar Powered Public Water Supply System – Level II, located at the Lingayen Gulf Resettlement Site, Brgy. Pangapisan Norte, Lingayen, Pangasinan, to wit:
