PROVINCIAL RESOLUTION NO. 590-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF JAIL MANAGEMENT PENOLOGY REGIONAL OFFICE I – SAN CARLOS CITY JAIL FOR THE PROVISION OF HEALTH CARE SERVICES TO PERSONS DEPRIVED OF LIBERTY (PDLs)

WHEREAS, the 1987 Constitution ensures the protection and promotion of the right of the people to health and guarantees the availability of essential health services to all the people at affordable cost through various plans and programs;

WHEREAS, it is the policy of the State to value human dignity and guarantee full respect of human rights, even for those in prison, thus, they should be provided with reliable, free and speedy healthcare services with standards that are similar to what is available in the community;

WHEREAS, the Bureau of Jail Management and Penology, a government institution mandated to promote humane safekeeping and provide developmental opportunities to PDLs in preparation for their community reintegration, is entrusted to ensure better and continuous health care management by proper referral and coordination to the nearest hospital or any government hospital institution and other health provider facility that will provide health care assistance and management of PDLs in times of emergency or between life and death situation;

WHEREAS, the Bureau of Jail Management Penology Regional Office I – San Carlos City Jail has requested the Provincial Government for the referral of PDLs relative to the provision of health care services;

WHEREAS, the Pangasinan Provincial Hospital, one of the fourteen hospitals operated by the Provincial Government of Pangasinan that offers multi-specialty health services including Laboratory, is the nearest government hospital within the vicinity of BJMP San Carlos City Jail that can provide immediate medical attention to PDLs;

WHEREAS, the Provincial Government of Pangasinan, through the Pangasinan Provincial Hospital, assumes the role of an active partner of the national government in a bid to advance healthcare access of Persons Deprived of Liberty (PDLs), and has agreed to be the referral hospital for the PDLs detained at the BJMP San Carlos City Jail, subject to the terms and conditions stipulated in the MOA;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Bureau of Jail Management Penology Regional Office I – San Carlos City Jail, represented by JSINSP Benjamin C Dulay, Acting Jail Warden;

NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the Bureau of Jail Management Penology Regional Office I – San Carlos City Jail for the provision of health care services to Persons Deprived of Liberty (PDLs);
