RESOLUTION NO. 599-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF STA. BARBARA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P8,695,010.08, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P8,695,010.08, which was enacted on March 18, 2024 through Appropriation Ordinance No. 2024-036, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;

2. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
4. That the appropriation & disbursement of the shares of LGU in the Fire Code Fees shall be in accordance with the DOF-DBM-DILG Joint Circular No. 2015-01, dated February 12, 2015, and the DBM-DILG-DOF Joint Circular No. 1, S-2023 dated April 17, 2023; and
5. That the appropriation for Service Recognition Incentive for CY 2024 shall be disbursed only upon issuance of guidelines granting the same, otherwise, the same shall be deemed bereft of legal basis.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


