RESOLUTION NO. 602-2024

DECLARING MUNICIPAL ORDINANCE NO. 157, S-2023 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, "AN ENTITLED **ORDINANCE** PRESCRIBING COMMITMENT TO **PANTAWID** PRIORITIZATION AND EXITED HOUSEHOLDS IN THE PAMILYANG PILIPINO DELIVERY OF SERVICES TO EXITED HOUSEHOLDS THROUGH THE ADOPTION OF THE CONVERGENCE PROVISION OF REPUBLIC ACT NO. 11310 IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 157, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv), 447 (a) (5) (xiv) of R.A. No. 7160, and R.A. No. 11310, otherwise known as the "Pantawid Pamilyang Pilipino Program (4Ps) Act,";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
