**RESOLUTION NO. 656-2024**

**DECLARING ORDINANCE NO. 08, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 08, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 447 (3) (i) of R. A. No. 7160 and Section 11 (f) of R. A. No. 11032, otherwise known as "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services";

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirements of public hearing and publication pursuant to Sections 187 & 188 of R.A. No. 7160;




