RESOLUTION NO. 693-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF BALUNGAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P26,514,401.35, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2024 involving total appropriations of P26,514,401.35, which was enacted on June 3, 2024 through Appropriation Ordinance No. 2024-02;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the grant of additional uniform/clothing allowance in the amount of One Thousand Pesos (P1,000.00) each to municipal officials and employees shall be in accordance with the provisions of Budget Circular No. 2024 – 1 of the Department of Budget and Management dated April 4, 2024;
3. That the disbursement of appropriation for Performance-Based Bonus for FY 2023 to qualified municipal officials and employees shall be held in abeyance until such time that the suspension issued by the Office of the President through Executive Order No. 61 dated June 3, 2024 shall be lifted and the guidelines implementing the same will be issued by proper authorities;
4. That the appropriation for Service Recognition Incentive (SRI) of municipal officials and employees shall be held in abeyance until such time that the circulars granting the same shall be issued by the proper authorities and shall be subject to Section 325(a) of R.A. No. 7160;
5. That the purchase of motor vehicle/s shall be subject to the provisions of Budget Circular No. 2022 – 1 of the Department of Budget and Management dated February 11, 2022 re “Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles”;
6. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG - NEDA - DBM -DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
7. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 2 for Calendar Year 2024 of Balungao, Pangasinan;
