**APPROVING RESOLUTION NO. 28, S-2024 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR FY 2024 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF FIFTY MILLION TWO HUNDRED SEVENTY FOUR THOUSAND ONE HUNDRED NINETY EIGHT PESOS AND FOURTEEN CENTAVOS (P50,274,198.14)”**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 28, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for FY 2024. This was endorsed by the Council, through MDC Resolution No. 01, Series of 2024 dated March 7, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of P50,274,198.14, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, and implementation of development projects of the LGU;

The projects proposed to be funded from the 20% Development Fund are based on Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and

3. Funding support for the SIP is embodied in the LGU's Supplemental Budget No. 1 for FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-01 dated May 13, 2024.


