Perez, Sr., popularly known as “Badong”, was a symbol of a vibrant leader and a strong pillar in the Municipality of San Manuel, having served as a Mayor from February 2, 1988 to June 30, 1998, then again from July 1, 2001 to June 30, 2010, making him one of the longest-serving Mayors of the Province of Pangasinan;

Perez, Sr. also served his hometown as Municipal Vice Mayor from July 1, 2010 to June 30, 2019, and after his political career, held the position as Local Legislative Staff Officer VI/Consultant to the Office of the Municipal Mayor from July 1, 2019 up to the time of his passing;

WHEREFORE, on motion of SP Member Noel C. Bince and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –


