RESOLUTION NO. 751-2024

DECLARING MUNICIPAL ORDINANCE NO. 04-06102024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE PRESCRIBING THE NEW FARE MATRIX OF MOTORIZED-TRICYCLE FOR HIRE WITHIN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 04-06102024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (1)(iii) (3)(vi) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Ordinance No. 04-06102024 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled “An Ordinance prescribing the new fare matrix of motorized-tricycle for hire within the Municipality of Pozorrubio, Pangasinan and providing penalties for violation thereof”;






