RESOLUTION NO. 777-2024

DECLARING ORDINANCE NO. 65, S-2022-25 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A PARCEL OF LAND CONSISTING OF TWENTY-EIGHT THOUSAND TWO HUNDRED FORTY-THREE (28,243) SQUARE METERS, OWNED BY COMMUNITIES PANGASINAN INC. AND LOCATED IN BARANGAY ANONAS, URDANETA CITY, PANGASINAN, FROM AGRICULTURAL TO RESIDENTIAL (R-5) USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its City Ordinance No. 65, Series of 2022-25 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the City of Urdaneta has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2017-2026; and a public hearing has been conducted which is a requisite under Section 20 of R.A. No. 7160;

WHEREAS, the Sangguniang Panlungsod submitted its Resolution No. 2545, Series of 2022-25 (Proposing the reclassification of a total of twenty-eight thousand two hundred forty-three (28,243) square meters located at Brgy. Anonas, Urdaneta City, Pangasinan and owned by Communities Pangasinan Inc. From agricultural to residential (R-5) use);
