**DECLARING SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR
YEAR 2024 OF TAYUG, PANGASINAN, INVOLVING A TOTAL
APPROPRIATION OF P18,354,822.15, OPERATIVE IN ITS
ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P18,354,822.15, which was enacted on July 1, 2024 through Appropriation Ordinance No. 2024-001;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;

2. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set aside as Quick Response Fund;
3. That the grant of increase in Representation and Transportation Allowance (RATA) shall be in accordance with the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management;
4. That the appropriation for additional government share in the premium contribution to the Home Development Mutual Fund (PAG-IBIG FUND) of municipal officials and employees shall be in accordance to DBM Circular Letter No. 2024-2 dated February 1, 2024;
5. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
6. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
7. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No 7160 (Use of Appropriated Funds and Savings).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Tayug, Pangasinan;
