PROVINCIAL RESOLUTION NO. 809-2024

EXPRESSING THE DEEP SENSE OF CONDEMNATION OVER THE SHOOTING OF SK CHAIRMAN EFREN C. DELA CRUZ OF SALOMAGUE NORTE, BUGALLON, PANGASINAN AND URGING THE PHILIPPINE NATIONAL POLICE AND OTHER LAW ENFORCEMENT AGENCIES TO EXPEDITE THE INVESTIGATION OF THE INCIDENT AT THE SOONEST TIME POSSIBLE

WHEREAS, SK Chairman Efren C. dela Cruz of Salomague Norte, Bugallon, Pangasinan was shot and wounded in his hometown, by unidentified assassin last Saturday, August 17, 2024 at about 8:00 o'clock in the evening on his way home;

WHEREAS, SK Chairman Efren C. dela Cruz is a young and vibrant public servant of the Province of Pangasinan and he does not deserve this act of lawlessness inflicted against him;

WHEREAS, the Sangguniang Panlalawigan strongly denounces this assault against an SK Chairman of the Province of Pangasinan;

WHEREAS, it is desired that a thorough investigation be conducted immediately by the concerned authorities in order to bring to justice the perpetrator/s and their principal/s and put them behind bars;

WHEREFORE, on motion of SP Member Joyce D. Fernandez, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to express, as it is hereby expressed, the deep sense of condemnation over the shooting of SK Chairman Efren C. Dela Cruz of Salomague Norte, Bugallon, Pangasinan and urging the Philippine National Police and other law enforcement agencies to expedite the investigation of the incident at the soonest time possible;
