**EXPRESSING SUPPORT TO CHRISTIAN LAZARO PASANA OF URDANETA CITY, PANGASINAN AS THE REPRESENTATIVE OF THE PROVINCE OF PANGASINAN IN THE “TAWAG NG TANGHALAN: THE SCHOOL SHOWDOWN” AS A SEGMENT NOONTIME PROGRAM OF “IT’S SHOWTIME” ON ABS-CBN KAPAMILYA CHANNEL**

**WHEREAS**, “Tawag ng Tanghalan: Year 8” is an amateur singing competition that currently airs as a segment of the noontime program “It’s Showtime” on pay television network Kapamilya Channel and a simulcast on A2Z, GTV, GMA and ALLTV every Mondays to Saturdays, and also airs worldwide via TFC, streamed online on Facebook and YouTube via Kapamilya Online Live;

**WHEREAS**, “Tawag ng Tanghalan: The School Showdown” is a special season featuring student contestants aged 14 and above who are enrolled in any school or universities in the Philippines, which has a format divided into four phases of examinations, such as Entrance (*Daily Rounds*), Preliminary (*Weekly Finals*), Middle-Term (*Semi-Finals*), and Final Exam (*Grand Finals*);

**WHEREAS**, in this special season of “Tawag ng Tanghalan”, which premiered on April 22, 2024, Christian Lazaro Pasana, a 20-year old native of Barangay San Vicente, Urdaneta City, Pangasinan, and a 2<sup>nd</sup> year Bachelor of Science Hospitality Management student of Phinma-University of Pangasinan, was a Final Exam Qualifier as he outshined the succeeding three phases of examinations showcasing his unique and exceptional renditions of all his winning pieces;

**WHEREAS**, under the mentorship of Renz Robosa as a vocal arranger/coach, Christian Lazaro Pasana won the battles during the Semi-Finals round for his powerful and soulful interpretation of the classic song “*I’ll Never Gonna Fall in Love Again*”, serving as the avenue for him to qualify for the Phase IV: Final Examinations, equivalent to the Grand Finals or *Huling Tapatan*;
