RESOLUTION NO. 941-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2024 OF THE CITY OF URDANETA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P14,406,565.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2024 involving total appropriations of P14,406,565.00, which was enacted on July 17, 2024 through Ordinance No. 69, Series of 2022-25;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

- 2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program and its Supplements thereto, of the city formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
- 3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- 4. That the grant of increase in Representation and Transportation Allowances (RATA) shall be in accordance to the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management;
- 5. That the grant of additional One Thousand Pesos (P1,000.00) in Clothing Allowance to all city officials and employees for Fiscal Year 2024 shall be in accordance with the provisions of Budget Circular No. 2024-1 dated April 4, 2024 of the Department of Budget and Management; and
- 6. That the appropriation for the additional government share in the premium contribution to the Home Development Mutual Fund (PAG-IBIG FUND) of city officials and employees shall be in accordance to DBM Circular Letter No. 2024-2 dated February 1, 2024.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 4 for Calendar Year 2024 of Urdaneta City, Pangasinan;
