RESOLUTION NO. 945-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF SAN QUINTIN, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P6,039,783.46, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2024 involving total appropriations of P6,039,783.46, which was enacted on August 19, 2024 through Appropriation Ordinance No. 3, S-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
2. That the implementation of the increase in Representation and Transportation Allowances (RATA) shall be in accordance with the Local Budget Circular No. 157 dated May 03, 2024;

3. That the disbursement of additional One Thousand Pesos (P1,000.00) for Uniform/Clothing Allowance shall be subject to DBM Budget Circular No. 2024-1 dated April 4, 2024;
4. That the employer (government) share in the premium contributions to the Home Development Mutual Fund (PAG-IBIG FUND) of municipal officials and employees shall be in accordance with the provisions of DBM Circular Letter No. 2024-2 dated February 1, 2024;
5. That the disbursement of appropriation for Service Recognition Incentive shall be in accordance with the guidelines granting the same; and
6. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplement thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


