#### PROVINCIAL RESOLUTION NO. 962-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH PEOPLE'S BROADCASTING SERVICE, INC. FOR THE PROVISION OF BROADCASTING SERVICES IN THE PROVINCE OF PANGASINAN GEARED TOWARDS THE IMPLEMENTATION OF ITS VARIOUS PROGRAMS AND PROJECTS

WHEREAS, one of the visions of the present administration is to strengthen various programs and projects on information and media relations of the Province;

**WHEREAS**, it is the objective of the Provincial Government of Pangasinan to reach wider audience and disseminate information to the public as fast and as accurate as possible by using radio broadcast;

WHEREAS, in order to realize the foregoing goal, the Provincial Government of Pangasinan shall enter into a contract with People's Broadcasting Service, Inc. in order to provide broadcasting services to the Province through the Station DZWN Bombo Radyo Dagupan on a blocktime programming type for the period October 19, 2024 to January 6, 2025 with its time placement as specified in the Contract;

WHEREAS, it is imperative for the Provincial Governor to enter into a Memorandum of Agreement with People's Broadcasting Service, Inc. for further information dissemination and to foster closer relationship and open communication with the community through the broadcast media;

WHEREAS, the execution of this Memorandum of Agreement is necessary for the Province of Pangasinan and the People's Broadcasting Service, Inc. for the provision of broadcasting services geared towards the implementation of the various programs and projects of the Province;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor, Ramon V. Guico III; and the People's Broadcasting Service, Inc., represented by Mr./Ms. J. Sarmiento, and Mr./Ms. F. Sabado, Station Manager/Account Executive;

**NOW, THEREFORE,** on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with People's Broadcasting Service, Inc. for the provision of broadcasting services in the Province of Pangasinan geared towards the implementation of its various programs and projects;
