PROVINCIAL RESOLUTION NO. 969-2024

INTERPOSING NO OBJECTION TO AND ENDORSING THE INSTALLATION, OPERATION AND MAINTENANCE OF THE YH PANGASINAN SOLAR POWER PLANT OF YHP3 ENERGY INC. AND YH GREEN ENERGY INCORPORATED LOCATED AT BARANGAY TOMBOD, IN THE MUNICIPALITY OF VILLASIS, PANGASINAN

WHEREAS, YHP3 Energy Inc. and YH Green Energy Incorporated, a renewable energy developer and solar power producer, has applied for and proposed to develop and operate a 19.5MWp generation capacity of YH Pangasinan Solar Power Plant at its identified project site located at Barangay Tombod in the Municipality of Villasis, Pangasinan;

WHEREAS, YHP3 Energy Inc. and YH Green Energy Incorporated, in its letter dated, September 27, 2024, has requested the Provincial Vice Governor, Mark Ronald DG. Lambino, a resolution of support and no objection to the proposed project;

WHEREAS, YHP3 Energy Inc. and YH Green Energy Incorporated has presented to the Sangguniang Panlalawigan the purpose of the project during its Regular Session held on October 14, 2024 and provided information in order to accelerate the energy program in the area;

WHEREAS, the Sangguniang Barangay of Tombod through Resolution No. 01, Series of 2022, dated May 28, 2022, have favorably endorsed the project to be established by YHP3 Energy Inc. and YH Green Energy Incorporated, at their barangay in Villasis, Pangasinan;

WHEREAS, Municipal Ordinance No. 200-050824 of the Sangguniang Bayan of Villasis, Pangasinan, reclassifying a 71,531 square meters, more or less, of agricultural land situated at Barangay Tombod in the said municipality, to industrial use, the subject matter of which is intended for the proposed solar power project;

WHEREAS, the Department of Energy has granted YHP3 Energy Inc., a Solar Energy Operating Contract (SEOC) No. 2022-10-639 on October 27, 2022 an exclusive right to explore, develop and utilize solar resources within the contract area in Villasis, Pangasinan;

WHEREAS, RA 9513, otherwise known as Renewable Energy Act of 2008 provides for the acceleration and encouragement for the exploration, development and utilization of renewable energy resources in the country;

WHEREAS, the establishment of an alternative source of power is a welcome development in the Province of Pangasinan in order to accelerate the energy program in the area apart from the socio-economic and environmental benefits that the host province will enjoy;

WHEREAS, subject to compliance with pertinent laws, existing rules, regulations and ordinances appurtenant to the implementation of the YH Pangasinan Solar Power Plant, the Sangguniang Panlalawigan interposes no objection to the request and consequently endorses the same;

NOW, THEREFORE, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to interpose, as it is hereby interposed, no objection to and endorsing the installation, operation and maintenance of the YH Pangasinan Solar Power Plant of YHP3 Energy Inc. and YH Green Energy Incorporated located at Barangay Tombod, in the Municipality of Villasis, Pangasinan;
