RESOLUTION NO. 970-2024

APPROVING RESOLUTION NO. 72, S-2024 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 2, CY 2024"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 72-S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Aguilar, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 2 for FY 2024. This was endorsed by the Council, through MDC Resolution No. 2, S- 2024 dated August 27, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱7,543,187.74, covers the augmentation of funds for Personal Services (to include Implementation of First Tranche of the Modified Salary Schedule for Local Government pursuant to Executive Order No. 64 S. 2024), Maintenance and Other Operating Expenses and Capital Outlay of various offices of the LGU and implementation of LDRRM projects and other priority programs of the municipality; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2 for FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2024 dated August 27, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Aguilar, Pangasinan;


