RESOLUTION NO. 998-2024

DECLARING MUNICIPAL ORDINANCE NO. 200-050824 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING SEVENTY ONE THOUSAND FIVE HUNDRED THIRTY ONE (71,531) SQUARE METERS, MORE OR LESS, OWNED BY BLUE CLOVER INC., SITUATED AT BARANGAY TOMBOD, VILLASIS, PANGASINAN COVERED UNDER TCT NO. 026-2024000934 AND TCT NO. 026-2024000936 FROM AGRICULTURAL LAND TO INDUSTRIAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 200-050824 the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 20 of R.A. No. 7160, and that the area (71,531 square meters, more or less) subject of reclassification is still within the prescribed limit of Villasis, Pangasinan;

WHEREAS, the Municipality of Villasis has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2013-2022, however needs updating; and the requisite of public hearing has been complied with and nobody posed no objection on the subject land area proposed for reclassification;

From Agricultural to Industrial Use);

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 200-050824 of the Sangguniang Bayan of Villasis, Pangasinan, entitled "An Ordinance reclassifying Seventy One Thousand Five Hundred Thirty One (71,531) square meters, more or less, owned by Blue Clover Inc., situated at Barangay Tombod, Villasis, Pangasinan covered under TCT No. 026-2024000934 and TCT No. 026-2024000936 from agricultural land to industrial use" as within the conferred powers of the Sangguniang Bayan to enact;
