PROVINCIAL RESOLUTION NO. 1049-2024

INTERPOSING NO OBJECTION TO AND ENDORSING THE PROPOSED SOLAR FARM PROJECT OF TERA RENEWABLES 4 CORPORATION (TR4C) IN BARANGAY BAYAMBANG, INFANTA, PANGASINAN

WHEREAS, Tera Renewables 4 Corporation, a subsidiary of CleanTech Global Renewables Inc. (CTGRI), an independent power producer and a renewable energy developer in the Philippines, has applied for and proposed the installation and development of the Solar Farm Project at its identified project site located at Barangay Bayambang, Infanta, Pangasinan;

WHEREAS, Tera Renewables 4 Corporation has presented to the Sangguniang Panlalawigan the purpose of the project during its Regular Session held on May 13, 2024 and provided information in order to accelerate the energy program in the area apart from the socio-economic and environmental benefits that Pangasinan as host province will enjoy;

WHEREAS, Municipal Ordinance No. 17, Series of 2024 of the Sangguniang Bayan of Infanta, Pangasinan, reclassifying 826,786.00 square meters, more or less, of agricultural land situated at Barangay Bayambang, Infanta, Pangasinan, to utilities, transportation and services land use, the subject matter of which is intended for the proposed solar farm project;

WHEREAS, the Department of Agrarian Reform and Department of Agriculture have granted the Tera Renewables 4 Corporation the Clearance for Reclassification, subject to the findings/recommendations of the Provincial Planning and Development Office, dated November 20, 2024, based on the DA Certification;

WHEREAS, the establishment of an alternative source of power is a welcome development in the Province of Pangasinan considering the present high cost of energy in the country;
