**DECLARING MUNICIPAL ORDINANCE NO. 175, S-2024 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE MUNICIPAL INTERNAL AUDIT SERVICE OFFICE AND POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (INTERNAL AUDITOR V) WITH SALARY GRADE 24 (SG-24) UNDER THE MUNICIPAL INTERNAL AUDIT OFFICE OF THE LOCAL GOVERNMENT UNIT (LGU) OF SAN NICOLAS, PANGASINAN, PROVIDING ITS QUALIFICATIONS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Civil Service Commission, the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447(a)(1) (viii) of Republic Act No. 7160;




