## **RESOLUTION NO. 103-2025**

DECLARING MUNICIPAL ORDINANCE NO. 176, S-2024 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 2, CREATION REDUCTION AND DISASTER RISK MUNICIPAL OF 3. AND SECTION MANAGEMENT OFFICE (MDRRMO) FUNCTIONS OF MUNICIPAL DISASTER RISK REDUCTION AND MUNICIPAL OF (MDRRMO) MANAGEMENT OFFICE ORDINANCE NO. 159, S-2023"AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 176, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447(a)(1)(viii) of R.A. No. 7160, Section 12 (a) (b) of R.A. No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010, Section 83 of R.A. No. 10352 or the General Appropriations Act of F.Y. 2013 and NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1 dated April 4, 2014 (Implementing Guidelines for the Establishment of Local DRRM Offices or Barangay DRRM Committees of the National Disaster Risk Reduction and Management Council, DILG, DBM and the CSC.
