APPROVING RESOLUTION NO. 2024-242 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO TWENTY-EIGHT MILLION SEVEN HUNDRED TEN THOUSAND ONE HUNDRED FORTY-FIVE PESOS AND ELEVEN CENTAVOS (P28,710,145.11)”

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2024-242 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan has identified items in their CY 2024 Supplemental Annual Investment Program (SAIP) No. 05. This was endorsed to the Sangguniang Panlungsod for approval on October 23, 2024 by the City Development Council Executive Committee thru Resolution No. 2024-08, Series of 2024, and was favorably acted upon by the Sangguniang Panlungsod on October 29, 2024 thru Resolution No. 2024-242;

2. Said SAIP cover fund for Maintenance and Other Operating Expenses of some city government offices, and the implementation of development projects and disaster risk reduction & management program of the LGU; and
3. Funding support for the implementation of the same in the amount of PhP28,710,145.11 is embodied in their proposed Supplemental Budget No. 04 for CY 2024 which was enacted by their Sangguniang Panlungsod thru Appropriation Ordinance No. 2024-05 on November 5, 2024 and approved by the City Mayor on November 19, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Alaminos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-242 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “Confirming/approving in toto the Proposed CY 2024 Supplemental Annual Investment Program No. 05 of the City of Alaminos, Pangasinan amounting to Twenty-Eight Million Seven Hundred Ten Thousand One Hundred Forty-Five Pesos and Eleven Centavos (P28,710,145.11)”;
