RESOLUTION NO. 107-2025

DECLARING MUNICIPAL ORDINANCE NO. 09-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN IN THE AMOUNT OF ONE HUNDRED NINETY-NINE MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND PESOS (P199,978,000.00) AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF ANDA, PANGASINAN REPRESENTED BY HON. JOGANIE C. RARANG – MUNICIPAL MAYOR AND THE LAND BANK OF THE PHILIPPINES REPRESENTED BY MR. CESAR N. ULPINDO – ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, TO FUND THE ACQUISITION OF LOT AND CONSTRUCTION OF NEW ANDA PUBLIC MARKET AND COMMON TRANSPORT TERMINAL INCLUDING SITE DEVELOPMENT INCLUDED IN THE APPROVED SUPPLEMENTAL INVESTMENT PROGRAM NO. 03 FOR CY 2024”AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 09-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) (b), 297(a) (b) (c), 444(1) (vi) and 447 (a) 2))iv) of R.A. No. 7160;




RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 09-2024 of the Sangguniang Bayan of Anda, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan in the amount of one Hundred Ninety-Nine Million Nine Hundred Seventy-Eight Thousand Pesos (P199,978,000.00) and other supporting documents pertaining to the loan entered into by and between the Municipal Government of Anda, Pangasinan represented by Hon. Joganie C. Rarang – Municipal Mayor and the Land Bank of the Philippines represented by Mr. Cesar N. Ulpindo – Assistant Vice President/Head, Pangasinan Lending Center, to fund the acquisition of lot and construction of New Anda Public Market and common transport terminal including site development included in the approved Supplemental Investment Program No. 03 for CY 2024” as within the conferred powers of the Sangguniang Bayan to enact;
