PROVINCIAL RESOLUTION NO. 1102-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN AND AMONG PANGASINAN STATE UNIVERSITY, DEPARTMENT OF SCIENCE AND TECHNOLOGY REGION 1, DEPARTMENT OF TECHNOLOGY - INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE, FOOD AND DRUG ADMINISTRATION, NATIONAL FISHERIES RESEARCH AND DEVELOPMENT INSTITUTE, BUREAU OF FISHERIES AND AQUATIC RESOURCES REGION 1, COMMISSION ON HIGHER EDUCATION REGION 1, DEPARTMENT OF TRADE AND INDUSTRY REGION 1, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES REGION 1, NATIONAL ECONOMIC AND DEVELOPMENT AUTHORITY REGION 1, AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY REGION 1, TO FORMALIZE THE COLLABORATION BETWEEN THE ASIN CENTER AND THE STEERING COMMITTEE MEMBERS

WHEREAS, the Pangasinan State University (PSU) established the Accelerating Salt Research and Innovation (ASIN) Center under the Department of Science and Technology Niche Centers in the Regions (NICER) Program, that is committed to promoting sustainable development by revitalizing the salt-making industry through research and development with the main goal of achieving 100% national salt sufficiency;

WHEREAS, to attain this goal, a Steering Committee composed of representatives from various agencies was formed which is responsible for providing strategic guidance, oversight, and policy development to effectively support the vision, mission and long-term objectives of the ASIN Center;

WHEREAS, constantly supportive of President Ferdinand R. Marcos Jr.'s Philippine Salt Industry Development Act which aims to strengthen and revitalize the salt industry in the Philippines, the Province of Pangasinan is one of the members of the Steering Committee;

WHEREFORE, in view of the foregoing, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –


