RESOLUTION NO. 1115-2024

DECLARING ORDINANCE NO. 17, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING THE RECLASSIFICATION FROM AGRICULTURAL ZONE TO UTILITIES, TRANSPORTATION, AND SERVICES ZONE OF LOT NOS. 6223-A, 6223-B, 6223-C, 6223-D, 6223-E, 6223-F, 6223-G, 6223-H, 6223-I, 6223-J, 6240, 6214-P, 6807 AND 6251 SITUATED IN BARANGAY BAYAMBANG, INFANTA, PANGASINAN WITH A TOTAL LAND AREA OF 826,786.00 SQUARE METERS FOR THE PROPOSED SOLAR FARM PROJECT OF TERA RENEWABLES 4 CORPORATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Municipal Ordinance No. 17, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the requisite of public hearing under Section 20 of the Local Government Code has been complied;

WHEREAS, the Municipality of Infanta has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2017-2026;
