APPROVING RESOLUTION NO. 84, S-2024 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 2 OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2024”

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 84, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council ExeCom of Calasiao, Pangasinan prepared the municipality’s Supplemental Annual Investment Program No. 2 for CY 2024. This was endorsed by the Council, through MDC Executive Committee Resolution No. 3, Series of 2024 dated August 16, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, covers the augmentation of funds for Personal Services (Implementation of the First Tranche of the Modified Salary Schedule for LGU Personnel), Maintenance and Other Operating Expenses and Capital Outlay of the LGU, and implementation of LDRRM program, GAD projects/activities and development projects of the municipality;

3. The project proposed to be funded from the 70% of the 5% LDRRM Fund conforms with Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);
4. The project proposed to be funded from the 20% Development Fund is based on Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
5. Funding for the SAIP in the amount of P12,604,720.07 is embodied in the LGU's Supplemental Budget No. 02, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 6, Series of 2024 dated August 21, 2024; and
6. The Supplemental AIP also includes infrastructure projects proposed for funding from the Department of Agriculture.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


