RESOLUTION NO. 113-2025

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR
CALENDAR YEAR 2024 OF MALASIQUI, PANGASINAN,
INVOLVING A TOTAL APPROPRIATION OF P15,022,293.00,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2024 involving total appropriations of P15,022,293.00, which was enacted on November 4, 2024 through Appropriation Ordinance No. 003-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the utilization of appropriations from FY 2022 shares of the Municipality from the Burley and Native Tobacco Excise Tax Collections under R.A. No. 8240 shall be subject to the provisions of Local Budget Memorandum No. 91 dated August 29, 2024;
2. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;

3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its Supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007; and
4. That the Local Government Unit failed to appropriate 5% DRRMF which is equivalent to P751,114.65 from the actual regular income pursuant to Section 324 (d) of R.A. 7160. The same shall be provided in the next Supplemental Budget of the Local Government Unit.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventenilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


