APPROVING RESOLUTION NO. 110-S-2024 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 3 FOR CY 2024 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN AMOUNTING TO P1,656,586.15 FOR THE REALIGNMENT OF VARIOUS FUNDS FOR THE IMPLEMENTATION OF FIRST TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL PURSUANT TO EXECUTIVE ORDER NO. 64 IN ACCORDANCE WITH LOCAL BUDGET CIRCULAR NO. 160 DATED AUGUST 12, 2024 PROVIDING FUNDS THEREOF”

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 110-S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 3 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 04-S. 2024 dated August 19, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
