### PROVINCIAL RESOLUTION NO. 1152-2024

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE LOCAL GOVERNMENT UNIT OF SAN JUAN CITY FOR THE ESTABLISHMENT OF A FRAMEWORK FOR MUTUAL COOPERATION TO PROVIDE ASSISTANCE AND SUPPORT SERVICES IN TIMES OF MAJOR DISASTERS AND EMERGENCIES**

**WHEREAS**, Section 12 of RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 *provides that* there shall be an established LDRRMO in every province, city and municipality, and a Barangay Disaster Risk Reduction and Management Committee (BDRRMC) in every barangay which shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction;

**WHEREAS**, Section 12 thereof also established a linkage/network with other LGUs for disaster risk reduction and emergency response purposes;

**WHEREAS**, Section 15 also provides that during emergencies, the LDRRMCs shall take the lead in preparing for, responding to, and recovering from the effects of any disaster;

**WHEREAS**, the Local Government Unit of San Juan City through the CDRRMO and the Province of Pangasinan through the PDRRMO have mutually agreed to expand good working relationship to enhance community disaster preparedness and coordinate disaster planning and response activities;

**WHEREAS**, the two local government units have committed to closely work together not only in implementing best practices for disaster risk reduction and management but also in enhancing their knowledge and expertise that will contribute to the improvement of their delivery of service to their respective communities;

**WHEREAS**, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall ensure the safety, welfare and well-being of their constituents and encourages inter-LGU cooperation for the efficient delivery of services and disaster management;

**WHEREAS**, Section 465 (vi) thereof further provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


**WHEREAS**, for the above purpose, a Memorandum of Understanding shall be entered into and signed between the Province of Pangasinan, represented by the Honorable Provincial Governor, Ramon V. Guico III and the Local Government Unit of San Juan City, represented by the Honorable City Mayor, Hon. Francis Javier M. Zamora;

**NOW, THEREFORE**, on motion of SP Members Vici M. Ventanilla and Nicholi Jan Louie Q. Sison, duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Understanding (MOU) with the Local Government Unit of San Juan City for the establishment of a framework for mutual cooperation to provide assistance and support services in times of major disasters and emergencies;
