RESOLUTION NO. 1175-2024

DECLARING ORDINANCE NO. 02-2024 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED “AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO SENIOR CITIZENS OF BURGOS, PANGASINAN AND APPROPRIATING FUNDS THEREFOR” WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 02-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in line with the objectives of Republic Act No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010” and Sections 17 (b) (2) (iv) & 447 (a) (5) (xvi) of R.A. 7160;

WHEREAS, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to provide an appropriation for the implementation of the subject ordinance beginning in the Annual Budget for 2025;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


