APPROVING RESOLUTION NO. 352, S-2024 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 5 WITH THE CY 2024 OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND SUPPLEMENTAL INVESTMENT PLAN OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 352, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Local Development Council revised their AIP to include new projects and endorsed the same to the Sangguniang Bayan for approval on August 29, 2024 through MDC Resolution No. 05, Series of 2024. This was favorably acted upon by the SB through Resolution No. 352, S.2024 on August 29, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. The previously approved AIP 2024 of the LGU was revised to include the disaster risk reduction programs/projects/activities proposed to be funded from the unexpended balances of LDRRMF CYs 2020 to 2023 in the amount of PhP10,815,000.00. This has emanated from the Municipal Disaster Risk Reduction and Management Council and approved through MDRRMC Resolution No. 01, Series of 2024;

4. The preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote:

6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 352-2024 of the Sangguniang Bayan of Asingan, Pangasinan, entitled "Approving the Municipal Development Council Resolution Number 5 with the CY 2024 of the Local Disaster Risk Reduction and Management Fund Supplemental Investment Plan of the Municipality of Asingan, Pangasinan";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Asingan, Pangasinan, for its information and guidance.
