RESOLUTION NO. 18-2025

APPROVING SB RESOLUTION NO. 50, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT PROJECTS WORTH OF ONE MILLION, SIX HUNDRED FIFTY-FIVE THOUSAND, FIVE HUNDRED FOURTEEN PESOS AND FOURTEEN CENTAVOS (P1,655,514.14) FUNDED BY THE REVERTED MUNICIPAL DEVELOPMENT FUNDS (MDF) OF FY 2024, 2023 AND 2022 OF THE MUNICIPALITY OF BANI, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Resolution No. 50, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. Funding support for the implementation of such will be sourced out from the realigned/reverted CYs 2024, 2023 and 2022 municipal development fund amounting to PhP1,655,514.14; and
2. Funds for the purpose is embodied in the municipality’s Supplemental Budget No. 03 FY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, S-2024 on October 21, 2024 and approved by the Municipal Mayor on October 28, 2024.


