RESOLUTION NO. 34-2025

DECLARING ORDINANCE NO. 231, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING ALL MOTORCYCLE RIDERS THE USE OF HIGH-VISIBILITY REFLECTIVE VEST, LUMINOUS-COLORED GARMENTS AND LIGHTS TO IMPROVE NIGHTTIME VISIBILITY IN THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 231, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of R.A. No. 7160, and Provincial Ordinance No. 325-2024";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


