RESOLUTION NO. 54-2025

DECLARING MUNICIPAL ORDINANCE NO. 2024-05 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE DECLARING ONE WAY ROUTE AT AMBROCIO STREET, BARANGAY PINDANGAN WEST, ALCALA, PANGASINAN FROM 6:00 O’CLOCK IN THE MORNING UNTIL 5:30 IN THE AFTERNOON DURING SCHOOL DAYS AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2024-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 447 (a) (1) (iii) (5) (v) & (vi) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


