RESOLUTION NO. 55-2025

APPROVING RESOLUTION NO. 426, S-2024 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 7, S. OF 2024 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 3 CY 2024 AMOUNTING TO SIX MILLION FOUR HUNDRED EIGHTY THOUSAND SEVEN HUNDRED THIRTY EIGHT PESOS AND 37/100 (P6,480,738.37)”

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 426, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program No. 7. This was endorsed to the Sangguniang Bayan for approval on November 12, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 7, Series of 2024;

2. The SAIP covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to qualified employees and officials), Maintenance and Other Operating Expenses (MOOE) of some municipal offices and implementation of priority projects of the LGU; and
3. Funding support for the full implementation of the same in the amount of Php6,480,738 is embodied in their Supplemental Budget No. 3 for CY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 3, S-2024 on December 9, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 426, S-2024 of the Sangguniang Bayan of Bautista, Pangasinan, entitled “Approving the Supplemental Investment Program of the Municipality of Bautista, Province of Pangasinan under MDC Resolution No. 7, S. of 2024 to be funded from the Supplemental Budget No. 3 CY 2024 amounting to Six Million Four Hundred Eighty Thousand Seven Hundred Thirty Eight Pesos and 37/100 (P6,480,738.37)”;
