**RESOLUTION NO. 10-2023**

**APPROVING SB RESOLUTION NO. 133, S-2022 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 02, CY 2022 OF THE MUNICIPALITY OF BANI, PANGASINAN FUNDED BY THE GENERAL FUND 2022”**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 133, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program (SIP) No.2 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 4, 2022 by the Municipal Development Council through Resolution No. 2022-9;
2. Said SIP covers fund augmentation for Personal Services (granting of Performance-Based Bonus to all qualified LGU employees and officials, and other personnel benefits) and Maintenance and Other Operating Expenses of some municipal government offices, and the implementation of priority development programs/projects of the LGU; and

- Funding support for the implementation of the same in the amount of PhP19,653,968.70 is embodied in their proposed Supplemental Budget No. 2 for Calendar Year 2022 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03-S.2022 on November 7, 2022 and approved by the Municipal Mayor on November 10, 2022.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;


