### RESOLUTION NO. 1000-2023

**DECLARING ORDINANCE NO. 016, S-2023 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE TEMPORARY ROAD CLOSURE OF A PORTION OF AVENIDA RIZAL EAST AND A PORTION OF THE STREET IN BETWEEN CENTROMART AND AGRI-AQUA PUBLIC MARKET FROM SEPTEMBER 15, 2023 TO JANUARY 15, 2024, FOR THE ESTABLISHMENT OF A NIGHT BAZAAR AND BARATILLO" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 016, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 21 (a) (c) and Article 43 of R. A. No. 7160;

**WHEREAS**, the Local Government of Lingayen shall provide alternate routes during the temporary closure of the subject municipal streets;
