DECLARING MUNICIPAL ORDINANCE NO. 2023-05 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE LOCAL YOUTH DEVELOPMENT OFFICE AND THE POSITION YOUTH DEVELOPMENT OFFICER II AND APPROPRIATING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2023-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Human Resource Management and Development Officer and the Local Finance Committee of the province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iv), 76, 78, 443 (c) (2) and 447 (a) (1) (viii) (5) and (xiv) of R. A. No. 7160; Section 2 (a) (b) (c) and (d) of Republic Act No. 8044, otherwise known as the "An Act Creating the National Youth Commission, Establishing a National Comprehensive and Coordinated Program on Youth Development, Appropriating Funds Thereof, and for Other Purposes"; and Republic Act No. 10742, or the "SK Reform Act of 2015";
