APPROVING RESOLUTION NO. 174-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PLAN NO. 03 CY 2023 INVOLVING AN AMOUNT OF EIGHT MILLION FOUR HUNDRED THOUSAND PESOS (P8,400,000.00) FUNDED FROM THE UNDERESTIMATED INCOME AND SAVINGS FROM OTHER MAINTENANCE AND OPERATING EXPENSES UNDER MAYOR'S OFFICE FOR PURPOSES OF FUNDING THE PROGRAMS IN THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 174-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

 The Local Development Council of Rosales, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 03 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on September 28, 2023 by the Municipal Development Council thru Resolution No. 0928 S.2023. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

- 2. The Supplemental Investment Program No. 3 with a total investment requirement of Php8,400,000.00 covers fund augmentation for Maintenance and Other Operating Expenses of various offices in LGU Rosales and implementation of development projects and disaster risk reduction activities of the LGU; and
- 3. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 03 for CY 2023, which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 03-2023 on October 2, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Rosales, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 174-2023 of the Sangguniang Bayan of Rosales, Pangasinan, entitled "Approving Supplemental Investment Plan No. 03 CY 2023 involving an amount of Eight Million Four Hundred Thousand Pesos (P8,400,000.00) funded from the Underestimated Income and Savings from Other Maintenance and Operating Expenses under Mayor's Office for purposes of funding the programs in the Municipality of Rosales, Pangasinan";
