**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 7 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2023**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 6 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 13-23;

WHEREAS, Supplemental Investment Program No. 7 contains programs, projects and activities that were not included in the approved 2023 Annual and Supplemental Investment Programs of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program covers the purchase of hospital/medical equipment to be funded from the loan proceeds from the Land Bank of the Philippines in the amount of P757,800,000.00 and implementation of other priority development projects of the province funded from Special Education Fund and other fund sources;

WHEREAS, the said Supplemental Investment Program likewise covers the needed counterpart funds for the implementation of PRDP sub-projects, namely: Construction of Pangasinan Bangus Breeding and Hatchery and Construction of three (3) units Warehouses with MPDP to be funded under the current 20% Development Fund (Counterpart for Community Development Project);

WHEREAS, the said Supplemental Investment Program also includes the purchase of livestock (goats) to enhance goat production and the purchase of rechargeable knapsack sprayers for the different DAR assisted ARB organizations which will be funded under the collaborative Province-led Agriculture and Fishery Extension System (PAFES) project of DA-ATI in the amount of P700,000.00 and the Sustainable and Resilient Agrarian Reform Community (SURE ARC) project of DAR amounting to P789,880.00, respectively;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


WHEREAS, after careful study of the said Program, this august Body finds it to be in order;
