**RESOLUTION NO. 101-2023**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR  
CALENDAR YEAR 2022 OF URBIZTONDO, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF P8,801,684.30,  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P8,801,684.30, which was enacted on December 19, 2022 through Appropriation Ordinance No. 4-2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the reversion of savings from the Personal Services shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

3. That the grant of Performance-Based Bonus for Calendar Year 2021 (PBB) for all municipal officials and employees of the municipality shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2021-1 dated June 3, 2021;
4. That the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) to regular and casual employees for Fiscal Year 2022 shall be subject to the provisions of Budget Circular No. 2022-04 dated December 20, 2022;
5. That the purchase of service vehicle shall be in accordance with the provisions of DBM Budget Circular No. 2022-1 dated February 11, 2022. (Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles);
6. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
7. That all programs, projects and activities shall be in accordance with the approved CY 2022 Supplemental Investment Program of the Municipality; and
8. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and that 30% shall be set aside as Quick Response Fund.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz. and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2022 of Urbiztondo, Pangasinan;




