**PROVINCIAL RESOLUTION NO. 1011-2023**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE LUZON MEDICAL SYSTEM FOR THE INSTALLATION, COMMISSIONING, OPERATION AND MAINTENANCE OF THIRTEEN (13) BRAND NEW DIALYSIS MACHINES TO BE LOCATED AT THE LINGAYEN DISTRICT HOSPITAL**

**WHEREAS**, the Province of Pangasinan has been tremendously embarking on new projects and programs to upgrade and rehabilitate its fourteen provincial government hospitals;

**WHEREAS**, the Provincial Government of Pangasinan, through the Lingayen District Hospital, in partnership with the Luzon Medical System intends to set up a Dialysis Center with thirteen (13) units of dialysis machine that could provide necessary services to patients needing dialysis treatments;

**WHEREAS**, the Province shall, in turn, exclusively purchase from the Luzon Medical System consumables necessary for the use and operation of the machines during the six-year agreement period;

**WHEREAS**, the equipment could further enhance better and more accessible ways of public health and medical services to the people of Pangasinan, especially the underprivileged;

**WHEREAS**, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

**WHEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


