**ENDORISING TO THE DEPARTMENT OF HEALTH THE  
APPLICATION OF THE EASTERN PANGASINAN DISTRICT  
HOSPITAL, PROVINCE OF PANGASINAN, FOR A PERMIT TO  
CONSTRUCT A THREE-STOREY BUILDING THEREAT**

**WHEREAS**, the Eastern Pangasinan District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 6<sup>th</sup> District of Pangasinan;

**WHEREAS**, there is a constant inflow of patients being serviced by the hospital;

**WHEREAS**, the Provincial Government of Pangasinan, through the Eastern Pangasinan District Hospital, intends to construct a three-storey building intended for the out-patient department and additional wards;

**WHEREAS**, the Eastern Pangasinan District Hospital and its medical staff are capable in running and sustaining the operations of the out-patient department and additional wards;

**WHEREAS**, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Eastern Pangasinan District Hospital to provide a more sufficient and higher level of medical and health services to its patients by the construction of a three-storey building;

**WHEREAS**, prior to the issuance of a license to construct, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct a health facility;
