PROVINCIAL RESOLUTION NO. 1015-2023

AUTHORIZING MS. CRISTY C. UBANDO, ASSISTANT PROVINCIAL TREASURER OF THE PROVINCIAL TREASURY OFFICE, AND DESIGNATED AS ACTING PROVINCIAL TREASURER, TO BE ONE OF THE SIGNATORIES OF THE PROVINCIAL GOVERNMENT OF PANGASINAN WITH LAND BANK OF THE PHILIPPINES AND OTHER GOVERNMENT DEPOSITORY BANKS OF THE PROVINCE

WHEREAS, Section 311 of the Local Government Code of 1991 provides that local treasurers shall maintain depository accounts in the name of their respective local government units with banks, preferably government-owned, located in or nearest to their respective areas of jurisdiction, and earnings of each depository account shall accrue exclusively thereto;

WHEREAS, in view of the official designation of Ms. Cristy C. Ubando, Assistant Provincial Treasurer, as Acting Provincial Treasurer, a request-letter from the Provincial Legal Officer, Atty. Baby Ruth F. Torre, dated October 27, 2023, was received by the Sangguniang Panlalawigan, for the passage of a resolution which will authorize the former to be one of the signatories of the Provincial Government of Pangasinan with Land Bank of the Philippines and other government depository banks of the province;

WHEREAS, it is necessary therefore to authorize Ms. Cristy C. Ubando to perform such functions, subject to the provisions of RA 7160 and other existing laws and regulations;
